Funding Light Rail Transit in UK Towns and Cities: CaMKOx The Test Case of Oxford Tuesday February 27th 2018

This half-day symposium at Westminster, sponsored by the All Party Parliamentary Light Rail Group (APPLRG) will bring together the arguments and evidence for using light rail and trams to transform historic towns and cities in the UK where new housing is being built. The test case of one of Britain's finest cities, Oxford, will be used to examine how the financial challenges can be resolved through sharing in the uplift in land values from development.

The symposium will be chaired jointly by Mr Iain Stewart, MP, Mr Daniel Zeichner MP and facilitated by Daniel Giblin of TramForward, and the results will be turned into a short report. After a series of short presentations an invited group of key stakeholders and transport experts will build a positive case that could form a prospectus for raising capital.
